H2OHIO PROJECT TOUR IN SENECA COUNTY:



Ohio Department of Natural Resources (ODNR) coordinated a tour of two H2Ohio Projects in Seneca County in June. Starting at the Clary-Boulee McDonald property, the Black Swamp Conservancy (current property owner) led the group through the upland portion of the preserve and down to one of the wetlands covering information relating to project background, planning, construction, and predicted impacts expected from this project.



Laura Johnson, (pictured above) Director of the National Center for Water Quality Research at Heidelberg University, provided additional information about the ongoing monitoring they and other agencies conduct on this and other sites.

Other monitoring partners in this area include Universities and agencies such as The University of Toledo, Bowling Green State University, The Ohio State University, and the Ohio Department of Natural Resources.



The group then drove to Fruth Wetland Nature Preserve where Linda Rose and I provided information on the H2Ohio grant process and project progression that has taken place since its' installation in 2020.



When the property was acquired in 2019, ODNR and the Water Quality Research Lab were given permission to install several wells at different depths so that long-term underground water quality could also be monitored in addition to the surface water monitoring in the wetlands. It was felt that this public site, situated around 3 miles from the landfill, made an ideal location for this long-term monitoring opportunity. The site is also an excellent location option for air quality monitoring instruments, should they become available for installation in the future.

The continued partnerships of multiple agencies conducting monitoring on this site has turned into a great resource for local environmental data collection to help other agencies in future regulation of quality-of-life aspects of this area, such as air and water quality.
